### **GENERAL SPECIFICATIONS**

Background information	Colombia has coastlines on the Atlantic Ocean, on the Caribbean Sea and on the Pacific Ocean. Colombia is an active member in the MACHC and is an established Hydrographic Service. Colombia has a well-developed maritime trade with 90% of Colombian imports and exports made through its seaports. However, an understanding of the importance of hydrography and how it underpins the Blue Economy is missing at the highest levels.
Justification of the project	To further enhance stakeholder engagement to support the ongoing development of hydrographic capability, maritime safety and the protection of the marine environment in a very sensitive sea area and to highlight the outstanding work that the Colombian Maritime Authority (Dirección General Marítima - DIMAR) carry out in developing capability in the region.

Explanation of the problem	Whilst DIMAR is well established and capable of meeting its SOLAS obligations lack of awareness and support at the highest levels jeopardises
