Subject: **Invitation to the XIth MACHC Meeting**

Dear Ms. Tsikata,

1. I am writing to invite you or your designated representative to the XIth meeting of the MesoAmerican and Caribbean Sea Hydrographic Commission (MACHC) from November 8-12, 2010 in Paramaribo, Suriname. First of all, let me introduce myself and the Organization I represent. I am Vice Admiral PALMER, the Director of Hydrography and Navigation of the Brazilian Navy, and the current MACHC Chair.

The MACHC is a regional arm of the International Hydrographic Organization (IHO). It's principal objectives are to work with participating nations to coordinate safety of navigation and promote hydrographic development, including the production and dissemination of Maritime Safety Information (MSI) in general, and hydrographic surveys (coastal mapping) and nautical charts in particular. The MACHC also promotes technical co-operation and training in the fields of hydrographic surveying, marine cartography and nautical information to assist countries expand their hydrographic capabilities. The important role of the MACHC is evident given that over 30% of the world's crude oil passes through the Caribbean on very large vessels, as does 50% of the world's cruise line traffic. In addition, the Caribbean has a hurricane season between June and November which has produced storms that can and do leave a trail of devastation on the islands and their coasts. They often leave dangers to navigation under the water that can be hazardous for life, property and maritime commerce. For these reasons, it is crucial that countries in the Region conduct hydrographic surveys to keep nautical charts and related navigation publications as up-to-date and accurate as possible. The MACHC facilitates and supports these critical collaborative activities.

2. As you are aware, Haiti is seeking international support for reconstruction of its infrastructure destroyed after the severe earthquake that occurred on January 12, 2010. Specifically, the Maritime and Navigation Service of Haiti (SEMANAH) is seeking IHO support for the establishment of a Haitian Hydrographic and Oceanographic Service (SHOH). The required support will include expert consultation on the organizational structure, donation of equipment and vessels, and development of professional personnel, among others. Further details will be provided later.

Some nations have already offered to support Haiti, including Brazil, Canada, Chile, France, Japan, Peru, The Netherlands UK, USA, and Venezuela, to date. The International Hydrographic Bureau (IHB - the Secretariat of the IHO) is coordinating this effort and organizing a Haiti Donors Meeting in conjunction with the upcoming MACHC meeting in Suriname the second week of November. The Donors meeting will begin the afternoon of November 9 and continue on the 10th and possibly the 11th, if necessary.

As part of the Donors meeting preparation, the MACHC identified the World Bank (WB) as a potential partner to maximize the potential respective resources brought to bear on this matter. Therefore, we would be very pleased if you or a designated representative could attend and provide a brief presentation on the WB reconstruction activities for Haiti and engagement requirements.

The majority of Hydrographic Offices that work within the Region and IHB representatives will be present at this meeting. I am certain this venue provides an excellent opportunity for the WB and the IHO community to get better acquainted with one another and begin a partnership with great potential for making a significant difference in the level of support provided to Haiti.

In the following annex you will find the logistical information and Registration Form for the meeting. The Agenda and corresponding timetable will be provided as soon as it is available.

3. Finally, knowing that this trip was unanticipated, I would like to offer 3 days of travel support (including airfare, lodging and incidentals at U.N. rates) for you or your representative to attend the meeting in Paramaribo.
