MACHC Integrated Chart Committee Wednesday, 18 June 2014 – Conference Call

1. Commencement of Call:

a. <u>Welcome & Introductions</u>: The Chair of the MICC, John Nyberg, opened the Conference Call with introductions of participants. The following participated in the call:

i. Jan Schaap (Netherlands) vi. Wilner Pino (Venezuela) ii. Ian Spurway (UK) vii. Anthony Klemm (US) iii. Paulo Matos (Brazil) viii. John Nyberg (US) Nickolás Roscher (Brazil) Erich Frey (US) iv. ix.

v. Alexander Fonseco Cardenas (Mexico)

The full list of MICC Members is provided as Annex B.

b. Approval of the Agenda:

No further changes were suggested and the Agenda was accepted as presented.

2. MICC Organization:

a. Participants List:

Venezuela informed the group that Arennis Zabala is no longer with the Venezuelan Hydrographic Office. The attached Participants List (Annex B) is adjusted accordingly.

b. Approval of Minutes from 19 March MICC Conference Call:

As there were no additional comments on the previous minutes, they were approved with no further adjustments.

c. MICC Administrative Actions:

There were no outstanding MICC Administrative Actions.

3. Risk Assessment Methodology:

The Risk Assessment Methodology introduced at the March 19 MICC Conference Call did not generate any follow-up interests. John Nyberg indicated that he reached out to those unable to participate in the March Call, but did not receive much response, other than from the UK, who provided some positive comments. John further noted that in order to proceed on a Risk Assessment exercise for the MACHC, all Member States need to be engaged, as it cannot be done by a single Member State as the only participant. John further suggested that a presentation on this topic be made to the next MACHC Plenary in Manzanillo in December. Mexico expressed interest in gaining further guidance on possible Risk

Assessments. Additionally Paulo Matos of Brazil expressed an interest in further exploring Risk Assessments Methodologies. The Chair urged all Member States to look at the minutes from the March 19 Call for further information on this topic.

Action 6.1: NOAA to send the Risk Assessment presentation (from the March 19 Conference Call) to Brazil. (Anthony Klemm)

4. INT Charts:

a. Review of INT Chart Actions:

- i. Action 12 (Venezuela and UK to review limits for INT 4102) remains on-going. Ian Spurway responded that there were discussions with Venezuela, but other technical issues need to be addressed before the limits can be resolved. Wilner Pino indicated that Venezuela intends to use INT 4102 for themselves.
- ii. Action 4.1 (UK to contact Colombia regarding the overlap and paper size of INT Charts 4025 and 4011) continues as **on-going**. Ian Spurway noted that this issue is in abeyance with technical issues at the moment.

b. <u>Updates to Current INT Chart Coverage:</u>

The INT Chart Scheme submitted by Mexico, discussed at the March 19 Conference Call has been adjusted based to comments and direct bilateral communications. As a result, the scheme was adjusted and a revised version is now available. Ian Spurway (UK) indicated that he is not fully comfortable with the chart scheme, but will defer until the adjusted scheme is reviewed. The Chair agreed to forward this latest update with the UK.

<u>Action 6.2:</u> The Chair, MICC, to forward the most recent Mexican Chart Scheme to the UK. (John Nyberg)

Instead of further discussing the chart scheme at this time, it was suggested that we await comments from CSPCWG and share those comments with MICC Members for the time being.

Alexander Fonseco stated that Mexico has requested the assignment of INT Chart numbers and is awaiting a response. This chart scheme has been forwarded to CSPCWG for review and eventual approval and assignment of numbers. As the numbers are received, they will be assigned accordingly. John Nyberg will continue to work with Jeff Wooton (of CSPCWG) to expedite receipt of the Chart Numbers.

<u>Action 6.3:</u> John Nyberg to work with Jeff Wooton, CSPCWG, to expedite receipt of the INT Chart numbers for the Mexican chart scheme. (John Nyberg)

John Nyberg also indicated that there will be a change to S-4, as CSPCWG intends to split Region A and Region B on the Pacific side. He further indicated that the Chart Numbers are expected within a week.

5. Electronic Charts:

- a. Review of Electronic Chart Actions:
 - Action 6 (UK and Celebrity Cruises (cruise industry) to discuss alternate sources of survey data and how/if it can be applied to charting products in the Bahamas) continues as on-going. (Ian Spurway noted that the UK is in receipt of information on Salvador Island.)
 - ii. Action 4.4 (Venezuela to provide update on the progress of ENC development in the Orinoco River area) remains as **on-going.** Wilner Pino noted that Venezuela is in discussion as to who will produce the Orinoco River ENCs. Venezuela does not have the authority for these ENCs at this time, although they did conduct surveys. It was suggested that Jeff Bryant (Capacity Building Committee) should be made aware of this. These discussions lead to an inquiry by Venezuela on possible training and/or assistance for the production of Inland/River ENCs. The Chair indicated that he would coordinate a response to Venezuela's request.

Action 6.4: John Nyberg to coordinate, in response to Venezuela's request, training and assistance for Inland/River ENC production for the Orinoco River. (John Nyberg)

- iii. Action 4.7 (UK to provide an update to the Ports Analysis) continues as **on-**
- iv. Action 3.1 (John Nyberg to contact other MACHC Members (individually) to gain support for expanding Risk Assessment efforts in the MACHC) is **completed**.
- v. Action 3.2 (Continue to work with CLIA (US) and Cruise Lines (UK) and make uses of AIS data to derive an updated list of Priority Ports) remains as **on-going**. It was suggested that this be made a joint US/UK action. The UK has a meeting scheduled with CLIA to discuss the requirements for data. The Chair suggested a possible US/UK Conference Call with the new CLIA representative.

<u>Action 6.5:</u> The Chair to arrange a US/UK Conference Call with CLIA to discuss hydrographic data requirements. (John Nyberg)

With respect to an updated list of Priority Ports, also an on-going activity which includes CLIA, the group discussed how AIS data might be helpful to determine such a list and NOAA agree to provide assistance with this effort.

<u>Action 6.6:</u> NOAA to provide support (to lan Spurway) for using AIS data to analyze cruise ship traffic in/out of ports, especially those that do not have adequate ENC coverage (Band 4 or 5). (Anthony Klemm)

- vi. Action 3.3 (The UK and NGA (Jim Rogers) establish contact to address the overlap of the two Haitian cells, GB40465A and GB400466) has been **deferred to the next meeting** (as Jim Rogers was unable to participate in this call).
- vii. Action 3.4 (Participants to forward comments on the Risk Assessment Models discussed under Agenda Item 3) is **completed**. See Item 3 above.

Ian Spurway noted the recent technical visit between the UK and Venezuela regarding the publication of GB301966. This cell will be available until Venezuela publishes their equivalent band cell. Anthony Klemm requested the shapefiles for GB 201966 so that it can be incorporated into the tables of available MACHC ENCs.

Action 6.7: Ian Spurway (UK) to forward the shapefiles for GB201966 to Anthony Klemm. (Ian Spurway)

Jan Schaap indicated that the Netherlands also has an interim cell available until Venezuela publishes their equivalent cell.

Ian Spurway also added that the UK will provide assistance to Cuba for Band 3 cells, one of which may create an overlap with US cells. Ian also indicated that a new Band 5 cell of the Mariel area has been completed. John Nyberg stated that it will be helpful if the geographic limits (shapefiles) for the Cuban cells could be made available for the MICC table of ENCs.

<u>Action 6.8:</u> Ian Spurway (UK) to forward the geographic limits (shapefiles) for the Cuban cells to Anthony Klemm. (Ian Spurway)

- b. <u>Cruise Lines Requests/Private Sources for ENCs:</u>
 - This is discussed under Action Items 6 and 3.2 above.
- c. Annex A: Details of Annex A were not further discussed.
- d. Annex B: Details of Annex B were not further discussed.
- e. <u>Updates on RENCs:</u> There were no updates on arrangements with RENCs.

Anthony Klemm referenced the new Mexican ENCs which became available since our last MACHC GIS update. Coordinates (and cell limits) for these ENCs will be required in order to update the GIS. Anthony Klemm will provide the list of ENCs to Mexico for which additional data is needed and e-mail them to Alexander Fonseco for the updates.

Action 6.9: Anthony Klemm to send list of newly published Mexico cells to request information to update MACHC GIS. (Anthony Klemm)

Anthony Klemm also noted that some of the names of the VE/UK cells covering Venezuela appear to have been interchanged in the Primar Catalog. John Nyberg agreed to follow-up on this issue with Wilner Pino.

Action 6.10: Anthony Klemm to follow-up via e-mail to clarify the switched cell name issue with Wilner Pino (Venezuela) – VE500104 and VE500105. (Anthony Klemm)

Wilner Pino, in turn, requested the shapefiles for the cells with switched names to be sent by Anthony Klemm.

<u>Action 6.11:</u> Anthony Klemm to send the shapefiles of all Venezuelan cells to Venezuela. (Anthony Klemm)

f. <u>ENC On-Line</u>: Anthony Klemm demonstrated the "ENC Online" concept which provides seamless presentation of the ENCs. This can NOT be downloaded and does NOT fulfill chart carriage requirements for regulated commercial vessels, but is useful for reference purposes, planning and GIS applications. John Nyberg suggested developing something similar for the MACHC Region. The current NOAA ENC On-Line

is available at: http://www.nauticalcharts.noaa.gov/ENCOnline/enconline.html. John asked everyone to look at the website, which can serve as a medium to provide data for the region. Further, he is considering submitting a proposal to the MACHC Plenary to further explore an ENC On-Line concept for the MACHC Members with each member will be in control of their own data.

Jan Schaap expressed interest and support for such an approach and looks forward to the proposal. Paulo Matos was similarly supportive.

Action 6.12: John Nyberg to develop a proposal for the MACHC on a Regional ENC Online for the MACHC. (John Nyberg)

6. MICC Work Plan for 2014:

John Nyberg noted that the next Conference Call scheduled for Oct 8 (in the Work Plan) will have to be changed due to the Extraordinary International Hydrographic Conference (EIHC) scheduled during that week. One alternative was for the MICC to actually have a face-to-face meeting in Monaco in conjunction with the EIHC. Unfortunately, most MICC Members could not confirm their attendance at the EIHC. Consequently the October 8 Conference Call has now been rescheduled for October 22, 2014. The Work Plan (Annex C) has been adjusted accordingly.

7. Other Business:

Paulo Matos expressed interest in more information on the Risk Assessment presentation from the previous Conference Call. Anthony Klemm will forward the Risk Assessment presentation to Paulo. See Action 6.1.

8. Adjourn:

The Conference Call adjourned at 10:45 EDT. The next conference call is now scheduled for October 22, 2014.
