MACHC Integrated Chart Committee
Wednesday, 1 November 2017 – Conference Call

1. Commencement of Call:

a. Welcome & Introductions:

The Chair of the MICC, John Nyberg, opened the Conference Call at 10:00. He thanked everyone for calling in this morning, noting that this is the last call prior to the MACHC Conference. This was followed with introductions of participants. The following Member States participated in the call:

b. Approval of the Agenda:

The Agenda was presented. No changes were suggested and the Agenda was accepted as proposed.

2. MICC Organization:

a. Participants List:

No changes or updates to the MICC Participant List were provided. (See Annex B).

b. Approval of Minutes from 9 August Conference Call:

c. MICC Administrative Actions:

- i. Action 8.1: (The MICC Chair to share additional information on the UN-GGIM Proposal with Brazil along with the website information when it becomes available.) is **completed**.

[John Nyberg noted as to where we are with respect to the GGIM WG and that the group was approved and is working on a Work Plan. They are going through statements from Member States and noting those who expressed interest. John

further encouraged those interested to contact your National GGIM representative and request to be included. John added that the first teleconference will be in the spring 2018. Finally John Nyberg suggested that we add GGIM to the next MICC Agenda]

Action 11.1: Add GGIM to the next MICC Agenda. (Erich Frey)

- ii. Action 5.1: (The MICC Chair to develop an article for HYDRO-INTERNATIONAL and potential other publications on the MACHC ENC Online) **remains active**. [There has been no action to date due to other priorities. However John Nyberg has contacted HYDRO-INTERNATIONAL, who expressed interest. John also asked for anyone to volunteer to move this effort forward. Chris Thorne (UK) expressed support for this effort.]

3. INT Charts:

a. Review of INT Chart Actions:

- i. Action 8.2: (The MICC to add “Update on the coverage of INT 4191” to the agenda of the Nov 1 MICC Conference Call.) is **completed**. [Bernice Mahabier (Suriname) indicated that MAS has started production of this chart with the UKHO. It was further stated that Jesse Murphy (US) has entered the chart into the IHO catalog and that Paulo Matos (Brazil), the MACHC INT Chart Coordinator, has reviewed it.]

b. INT Chart Coordinator:

The INT Chart Coordinator was unable to participate today and consequently there were no further INT Chart updates.

c. Updates to Current INT Chart Coverage:

The Suriname INT Chart 4191 update was covered under Action 8.2, above.

4. Electronic Charts:

a. Review of Electronic Chart Actions:

- i. Action 8.3: (ALL MACHC Member States are to review and forward revisions and/or additions to the Ports List to Jesse Murphy by Nov 1, 2017) is **completed**.
- ii. Action 8.4: (Venezuela to provide a summary update on the Orinoco River Project to MACHC in December.) **remains active**. [John Nyberg indicated that the information on the Orinoco River project has been received and reiterated his request that Venezuela provide an update at the MACHC in December.]
- iii. Action 8.5: (MICC Chair to provide additional information on the “Sustainable Development Goal in the Caribbean” Meeting in January 2018.) **remains active**. [John Nyberg noted that he has not received anything further other than that there is a meeting in Jamaica in January. Bernice Mahabier (Suriname) suggested that each Member State include GGIM in their National Reports.]

John Nyberg endorsed this suggestion and further suggested that Leonardo Tun ask Member States to include GGIM in their presentation to the MACHC Plenary.]

- iv. Action 7.3: (IC-ENC and Mexico to engage in direct communication to address the overlap and ENC release of Mexican ENCs issue, noting the status and expected course of action and report to the next meeting) **is completed.**

b. Ports Analysis Update

Jesse Murphy indicated that there was a good response on this effort. Cuba provided information on several Band 4 and 5 cells which have been forwarded to IC-ENC for validation. Mexico provided updates on 8 cells. Venezuela provided information on 4 new cells and progress on the Orinoco River project. Jesse added that there are some Ports on the list which perhaps should be removed, as they appear to be outliers. Leonardo Tun (Mexico) agreed and will take a closer look at some of those Ports in Mexican waters, since they do not appear to be a priority.

Action 11.2: Mexico to re-examine the priority ports list with the goal to removing those not supported by the data. (Leonardo Tun)

c. Update to Gaps Analysis

Stephanie Vincent (UK) added that the UK has Band 6 and 5 coverage of San Salvador and that they are also re-scheming coverage of St. Vincent and the Grenadines. Further, Stephanie added that she will put all the relevant information in an e mail. Jim Rogers (US) indicated that the U.S. Coast Guard has produced some charts and that he would provide further information.

Jan Schaap inquired as to why we would remove some ports from the list. John Nyberg explained that some areas were identified as ports due perhaps a vessel temporarily anchoring in an area, which may have appeared as a port but was not supported by follow up data.

d. ENC On-Line

John Nyberg asked everyone to provide their latest updates to Jesse Murphy by November 10. He further emphasized that we would like to have as much up-to-date information as possible for the MACHC Conference. Further, John requested that all Member States who are participating in ENC On-Line (Brazil, Colombia, Cuba, Mexico, Netherlands and U.S.) to provide updates. Although it was initially suggested that these Member States inform IC-ENC that their ENC On-Line data can be provided, Mike Hawes (IC-ENC) suggested that IC-ENC provide the updates from all those who have already agreed in the past.

e. Updates on Overlaps

Jesse Murphy noted one overlap between the U.S. and Mexico. This is expected to be resolved shortly.

f. Updates on Arrangements with RENCs

There were no indications that any changes occurred on arrangements with RENCs and this was not further discussed.

5. Other Business:

Prior to ending the call, the MICC Chair, John Nyberg noted that the U.S. will be unable to travel to Cuba and that he regrets seeing all of our colleagues. He added however that we will prepare the Agenda for the MICC Meeting, the MICC presentation to the MACHC Plenary and a Work Plan for 2018. Paulo Matos, the MICC Vice Chair will conduct the MICC Meeting in Cuba.

John noted the following highlights to note at the MACHC Conference:

- Progress on the Ports List
- Progress on the Orinoco River Project

Finally John asked all Member States to provide updates on anything you would like to highlight to Jesse Murphy by November 10. Additionally, John asked if anyone can identify new Members, who wish to be included in the ENC On-Line, to provide the relevant information to Jesse Murphy by November 10.

Action 11.3: All Member States to provide updates on anything they would like to highlight to Jesse Murphy by November 10.
